

## **Mauritius Telecom Facebook Quiz – World Telecommunications Week Terms & Conditions**

This contest is organized by Mauritius Telecom Ltd (“MT”) on its official Facebook page. Eligible participants may answer quiz questions and stand a chance to win prizes by following the participation rules outlined in the contest post.

### **1. Acceptance**

1.1 By entering this contest, the participant agrees to be bound by these Terms and Conditions and confirms having read and understood them.

1.2 By entering this contest, the participant agrees that MT may use his/her personal details solely for the purpose of administering the contest, in accordance with MT’s Privacy Policy and applicable data protection laws of the Republic of Mauritius.

1.3 The participant agrees that MT may publish, without compensation, his/her full name and/or photo if declared a winner, for promotional purposes.

1.4 By participating, the participant agrees to release and hold harmless MT, its subsidiaries, directors, employees, agents, and partners from any liability arising from participation in the contest or use of the prize.

1.5 MT reserves the right to amend these Terms and Conditions at any time without prior notice.

### **2. Eligibility and Entry Restrictions**

2.1 To be eligible, participants must:

- (a) be aged 18 years or above.
- (b) have a valid and authentic Facebook account.
- (c) comment on the campaign post with the correct answer.
- (d) not be an employee of MT or any of its affiliates or subsidiaries.

2.2 Only one (1) entry per person and per Facebook account is permitted. MT reserves the right to disqualify duplicate, fraudulent, or suspicious entries.

2.3 Only participants who provide the correct answer will be eligible for the draw.

2.4 The contest will run within the dates and times specified in the contest post. All times are in Mauritius Time (GMT+4).

2.5 Any entries submitted outside the contest period will be deemed invalid.

2.6 Any misrepresentation or failure to comply with the above criteria will result in automatic disqualification.

a) The prize is non-transferable and cannot be exchanged for cash.
